At Fewpips, we use various digital technologies to enhance your experience, secure our platform, and analyze how users interact with our virtual trading environment. This Policy explains what these technologies are and how you can manage them.

### **1. DATA CONTROLLER & CONTACT**

### **2. UNDERSTANDING COOKIES & TRACKING**

Cookies are small data files stored on your browser or device. They allow us to recognise you, remember your preferences (like language or login state), and detect suspicious activity.

In addition to cookies, we utilise:

- IP Logging: Tracking the unique address of your device to prevent unauthorised access from prohibited regions.
- Analytical Scripts: Small snippets of code used to understand how you navigate our dashboard, which helps us optimise platform performance.

### **3. MANAGING YOUR PREFERENCES**

Most modern web browsers allow you to control cookie settings. You can set your browser to block all cookies or notify you when one is being sent.

**Note on Functionality:** Our platform relies on Necessary Cookies to function. If you disable all cookies, you may be unable to log in to your Fewpips dashboard or execute trades in the simulation environment.

### 4. TYPES OF COOKIES WE DEPLOY

#### **A. Mandatory (Essential) Cookies**

These are vital for the security and basic operation of the Website. They enable core features like user authentication and fraud prevention. These expire at the end of your session and cannot be disabled.

#### **B. Functional (Preference) Cookies**

These remember your personalised settings, such as your chosen theme or account currency. We store these until you clear your browser cache or withdraw consent.

#### **C. Analytical (Performance) Cookies**

We use these to monitor traffic patterns and platform stability. This data is generally aggregated and helps us identify which challenge models are most popular.

#### **D. Marketing & Targeting Cookies**

Fewpips and our partners use these to deliver relevant advertisements and measure the effectiveness of our marketing campaigns. If you have visited our site, these cookies may show you Fewpips offers on other platforms.

### 5. YOUR LEGAL RIGHTS

Under global data protection standards, you have specific rights regarding your digital footprint:

- **Right of Access:** You may request a copy of the personal data we hold about you.
- **Right to Rectification:** You can update inaccurate data via your user account.
- **Right to Erasure:** You can request the deletion of your data (subject to our AML and Anti-Fraud retention requirements).
- **Right to Object:** You can object to data processing based on our legitimate interests or for direct marketing.
- **Withdrawal of Consent:** You may revoke cookie consent at any time by clearing your browser data.
